Court is advised that certain grand jury transcripts previously ordered to be disclosed in fact were not disclosed to the defendants. The Court orders the Government to turn over all of the October 14th grand jury transcripts to the defendants by not later than 9:00 a.m, June 28, 2011. In light of this disclosure, the Court will allow the parties to file supplemental briefs to the Motion to Dismiss Case and the Indictment with Prejudice Due to Repeated and Intentional Government Misconduct [505]. The defendants' supplemental brief must be filed by not later than July 18, 2011. The Government's opposition must be filed by August 1, 2011 and any reply thereto must be filed by August 15, 2011. The hearing on the aforementioned motion is continued to September 8, 2011 at 3:00 p.m.

Court also orders the Government to provide the defendants with the names of all witnesses who testified before the grand jury, the dates of the their testimony, and the names of the Government attorneys present during each witness's testimony. The Court further orders the Government to turn over to the defendants all of the Government's "comments" during all of the grand jury proceedings.
