- 2) Your ability to fill this need through awareness, collaboration, and engagement




Federal judiciary

- When all vacancies are filled, our federal courts have 890 Article III judges in total:
 - One Supreme Court with nine justices,
 - 13 circuit courts with 179 judges,
 - 94 district courts with 677 judges and
 - One Court of International Trade with 9 judges
 - One Court of Federal Claims with 16 judges
- ~1700 total federal judges



Federal judiciary





Federal judiciary

- The Supreme Court only hears 100-150 cases a year out of 7,000 appeals
- By contrast, the appellate courts hear approximately 50,000 appeals each year
- District Courts hear approximately 350,000 cases each year
- Nearly 70,000 criminal defendant filings in federal district court in 2023



State judiciary

- 50 states, 50 systems
 - DC + federal territories (quasi-federal)
- High court goes by different names
 - Supreme Court, Court of Appeals, etc.
- Different methods of appointment and election
- 30,000+ state judges
- Trial Courts and Appellate Courts



Compelling Need

Judicial diversity = varied professional and demographic backgrounds on the bench.

- 1) Judicial diversity matters (federal and state)
- 1) Judicial diversity, especially for public defenders and criminal defense attorneys in general, is lacking



Judicial Diversity Matters

Numerous studies/reports produced by AFJ and coalition partners prove what may be common sense:

The professional and demographic backgrounds of judges makes a difference in 1) what they rule, 2) whom they hire, and 3) how their courtroom runs.

- The results provide evidence that criminal cases assigned to federal district judges who are former public defenders are less likely to lead to incarceration.
- In addition, for charges proceeding to a trial, assignment to a former public defender results in incarceration sentences that are about 16 months shorter on average.
- Former public defenders' lower likelihood of handing down extremely long sentences—30 years or more—partly drives this result.



- "In cases where race, gender, and religion are at issue, a judge's identity can have a significant impact on how cases are decided."
- "Studies on federal appellate courts have found that having at least one [woman] on an appellate court panel significantly increases the likelihood that male judges will find for plaintiffs in cases involving sexual harassment and discrimination, while having at least one Black judge on a panel increases the likelihood that non-Black judges will find for plaintiffs claiming violations of the Voting Rights Act and in affirmative action cases."

- This report finds that just seven Supreme Court decisions have caused economic harm to at least 74 million people since 2011, including workers, renters, consumers, and low-income people without health insurance.
- Report provides numerous examples of cases where judges with economic justice/labor backgrounds ruled for the worker, where fellow judges in the same cases from corporate backgrounds ruled for the employer
 - Economic Justice, Judges, and the Law, Alliance for Justice



Judicial Diversity is Lacking

State Supreme Courts:

- Nearly 2 out of every 5 justices on State Supreme Courts carry prosecutorial backgrounds.
- 1 out of 10 carries a background as a public defender.
- Out of 345 justices nationwide, not even 25 carry a background in civil rights, and barely 3% of state supreme court justices have backgrounds in civil rights outside of government practice.
- Demographically, it's the rare state supreme court that has a justice who comes from the Hispanic, Asian, or from a Native American community.

- 1) Partisan election
 - North Carolina
- 2) Nonpartisan election
 - o Georgia, Oregon
- 3) Legislative election
 - Virginia, South Carolina
- 4) Gubernatorial appointment
 - California, interims
- 5) Selection committee/assisted appointment
 - Missouri

- FBI vetting
