## POSITION ANNOUNCEMENT ASSISTANT FEDERAL PUBLIC DEFENDER

**The Federal Public Defender for the Middle District of Pennsylvania** is seeking an Assistant Federal Public Defender (AFPD) for the Capital Habeas Unit (CHU). This is a full-time attorney position in the Harrisburg office. The Capital Habeas Unit represents death-sentenced prisoners in federal habeas corpus proceedings. To achieve our mission, we value an office culture that attracts, recruits, supports, inspires, and sustains a diverse workforce to provide the highest quality of legal service in all that we do.

**<u>RESPONSIBILITIES</u>**: An AFPD in the CHU represents petitioners in capital habeas cases in federal court from the initial petition through all subsequent federal hearings and appeals. An AFPD is responsible for providing legal guidance and leadership to collaborative teams of paralegals, investigators, and research and writing attorneys, on each of their cases. Due to the complexity and duration of capital habeas proceedings, an AFPD analyzes complex and diverse records, pursues relevant training on a continuing basis, and is responsible for establishing and maintaining ongoing communication and consultation with expert witnesses and other counsel representing their clients.

**REQUIREMENTS AND QUALIFICATIONS:** An ideal candidate will possess excellent written and oral persuasive narrative skills, a proven commitment to public interest law and experience in at least one of the following areas: criminal law, Pennsylvania post-conviction litigation, or habeas corpus litigation. A background in any area of mental health and/or social work is helpful. In addition to strong communication and interpersonal skills, capacity to work independently and collaboratively and an ability to prioritize and meet critical deadlines with team leadership is essential. Fluency in Spanish is a plus. An AFPD must be an attorney admitted and in good standing before a state bar and eligible for admission to the bars of the Middle District of Pennsylvania, the Court of Appeals for the Third Circuit, and the United States Supreme Court. The successful candidate will possess a valid driver's license and the ability to travel in and out of state, and work weekends, evenings and holidays as needed.

**SALARY AND BENEFITS:** This is a full-time, ungraded position with federal salary and benefits based on qualifications and years of experience, consistent with federal guidelines and regulations. This position is subject to mandatory Electronic Funds Transfer (direct deposit) participation for payment of net pay. Employees of the Federal Defender are members of the judicial branch of government; they are considered "at will" and are not covered by the Civil Service Reform Act. The selected candidate will be subject to a background check as a condition of employment. Our CHU is in Harrisburg, the #1 city to live in Pennsylvania according to 2023 U.S. News and World Report, telework is currently available two days per week at the discretion of the Federal Public Defender, and while AFPDs are required to be in the office regularly as team leaders, remote work with routinely scheduled travel to the office may be considered for an ideal candidate.
